7. The decision of the Selection Committee appointed by the Executive Director, AIIMS Kalyani, will be final, and no representation in any manner will be entertained in this regard. Applications incomplete in any aspect will be summarily rejected, and no intimations/requests will be made to the candidate. Candidates who will be called for the final interview will be based on the complete discretion of the Selection Committee, and no individual intimations will be given/sent to the candidate in this regard.

TERMS AND CONDITIONS:

1. **Disqualification:** The candidates are responsible for ascertaining and ensuring their eligibility as per the prescribed qualification and experience. If any declaration given or information furnished by him/her proves false or if he/she is found to have wilfully suppressed any material or information, he/she will be liable for removal from service and such other action as the Government/ ICMR may deem necessary. Even after qualifying in the selection process, the candidate may be disqualified during document verification if he/she does not fulfill essential eligibility criteria. Canvassing of any kind will lead to disqualification.
2. **Tenure:** These are tenure vacancies under funded project and are not employment on AIIMS Kalyani pay roll. The assignments are purely on a contract basis for a period of 12 months (which can be extended to a maximum of 3 years (36 months) based on performance and funding availability). These appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS, Kalyani/ICMR, or continued contractual appointment.
